

Chi Chapter Selects Steve Harter for Service Award

The Chi Chapter of Beta Phi Mu is delighted to announce that Stephen P. Harter, Professor Emeritus at SLIS, is the winner of this year's service award. The award is given annually to individuals who have made major contributions to library and information science.

Holding a Ph. D. from the University of Chicago, Prof. Harter joined the SLIS faculty in the early 1980s and retired in 1999. During his years at SLIS, Prof. Harter was recognized for



excellence in both teaching and research. He not only chaired numerous doctoral committees but also mentored Ph.D. students and junior faculty, frequently co-authoring with them. His major interests included bibliometrics, information retrieval, and research methodology. Among his numerous service activities, Prof. Harter edited the prestigious journal *Library Quarterly*, chaired the SLIS Promotion and Tenure Committee, and served as the faculty advisor to Beta Phi Mu.

Prof. Harter is an internationally known researcher and author. He wrote two influential books: *Research Methods in Librarianship: Techniques and Interpretation*, co-authored with Charles H. Busha and published by Academic Press in 1980, and *Online Information Retrieval: Concepts, Principles, and Techniques*, published by Academic Press in 1986. The book on research methodology was translated into Spanish and published in 1990 by the

Universidad Nacional Autonoma de Mexico under the title *Metodos de investigacion en bibliotecologia: tecnicas e interpretacion*. Moreover, in a number of studies Prof. Harter has been ranked among the most highly cited researchers in the entire field of library and information science.

The Service Award will be presented at the Chi Chapter Initiation ceremony in the Indiana Memorial Union on April 11th. Please join us in honoring him!

Career Forum Draws Students

The Chi Chapter of Beta Phi Mu and the SLIS student chapter of ALA co-sponsored a Career Panel on October 11th, 2002 at IU Bloomington. The Panel was part of SLIS career week activities. The topic of the panel discussion was two-pronged: *"What to do when they offer you the job,"* and *"Building your LIS resume and other job-hunting tips."* Attendance was excellent! Featured speakers were Jan Gillespie from INCOLSA, Chris Knott from the Georgetown Law Library, David Lewis from IUPUI, and Cass Owens from Monroe County Public Library. The panel of speakers covered wide-ranging topics, including: how to size up a potential new job, which type of resume is best, what is the employment outlook for LIS positions, what questions should job seekers ask of potential employers, and how one determines a fair salary. These topics represent just a sampling of the issues addressed.

National BPM Scholarships Available

Multiple scholarship and fellowship opportunities exist for BPM members.

One is the Frank B. Sessa Scholarship for Continuing Professional Education (\$1,250). This scholarship is awarded to librarians to increase their professional skills through additional study or attendance at a formal program or workshop. No application form is required. Requirements for this scholarship include:

- Current vita
- 1-2 page typed description of your plans for study and the relevance to your present job and your plans for the future.

The scholarship is awarded on:

- Plan of study
- Usefulness of the planned study to the applicant's present job, and/or
- Usefulness of the planned study to the applicant's future professional endeavors

Continuing professional education should not be interpreted exclusively as attendance at formal programs or workshops but can be activities that will increase the professional skills of the recipient. The Scholarship gives very low priority to those applicants who are pursuing a formal degree program.
