Major Course Assessments

Case conceptualization papers: You will be required to submit TWO case conceptualization papers in this course. The first must be a clinical case conceptualization of a current client. The second will be a theoretical application of that case from an evidence-based theoretical position.

Case presentation: You will be required to "staff" the case through a case conceptualization presentation. This will be a 10 minute presentation of the case to your classmates, including presenting issues, treatment plan and your case conceptualization from a theoretical perspective.

Reflections: At the midpoint and the end of the semester, you will be required to ask for feedback from your site supervisor and your faculty supervisor about your skills as a professional counselor. Upon receiving this feedback, you will submit a critical reflection of your skills as a counselor. This should include areas of strength and those areas that you are still developing. In this paper, you must provide at least 3 strategies for how you will improve your areas of weaknesses. Minimum 5 pages, maximum 7 pages. Your paper should follow APA style.

Participation: As a graduate student, it is critical that you engage in a professional and critical manner with the course content and instructor. You will be expected to participate in class discussions in each class session.
