### **Course Key Assessments**

Two Exams: You will have two content exams that cover all material in class and in Canvas. These will contain a variety of questions to assess student learning. Any information that is taken and quoted directly from the text to serve as a response will result in a grade of zero for that section of the response within essay question responses. 100 points possible for each exam. There will be no dropped exams this term so you may be allowed to make up an exam for any of the following reasons (e.g., illness, death or serious illness in family, etc.). To do so you must contact me no later than 24 hours after the missed exam to set up a date to retake the exam. You will then have seven days to complete the exam or a grade of zero will be entered for the exam. Makeup exams will be essay questions only.

**Video-based project:** You will be required to submit a series of videos of mock interviews where you show interpersonal and non-verbal interventions, as well as evidence-based therapeutic techniques relevant to a mock case.

Case Conceptualization: You will be provided a mock case whereby you will develop a treatment plan based on current evidence and culturally relevant factors. You will also be required to identify potential personal biases and how to ethically handle these within the context of the case.

**Documentation exercises**: You will be given mock cases and will be required to develop relevant treatment goals based on the diagnosis provided. The treatment must be the most appropriate, evidence-based treatment for that specific disorder.

Outcome Questionnaire 45: You will administer and score the OQ45 and submit a report that explains the importance of monitoring progress toward treatment goals.

**Participation:** As a graduate student, it is critical that you engage in a professional and critical manner with the course content and instructor. You will be expected to participate in class discussions in each class session.
